May 10, 2022 Cabinet Decisions 22-004 Majuro, Marshall Islands [English]

On March 9, 2022 the Cabinet made the following eight (8) decisions...

- 1. The Cabinet appointed Mr. Michael Konelios as Chairman of the Public Service Commission for a term of three years replacing Chairman Kenneth Anitok.
- 2. The Office of the Chief Secretary (OCS) Strategic Plan (2022 2026) was approved by the Cabinet. The OCS Strategic Plan provides the framework of objectives, activities, timelines and performance indicators.
- 3. The Cabinet approved the composition of the Passport Panel as follows: Assistant Attorney General (Criminal Division) as the Chairperson, Assistant Attorney General (Civil Division), Director of Passports & Citizenship as the Secretary, Director of Immigration, and Assistant Secretary of Administration for Ministry of Foreign Affairs & Trade.
- 4. The Cabinet approved the resolution regarding the RMI's support to the Republic of China (Taiwan's) inclusion in the United Nations.
- 5. The Cabinet approved the resolution regarding the RMI's solidarity with the People and Government of Ukraine and condemns the Russian Federation for the invasion of Ukraine.
- 6. The Bill for an Act to repeal Public Law 2021 39 was approved by the Cabinet. The Non-Profit Entities (Amendment) Act, 2022 is to ensure that the creation, registration, governance and dissolution of non-profit entities engaging in activities in the RMI is done in accordance with international standards and international commitments of the RMI.
- 7. The Cabinet approved the proposed amendments to Title 7 of the Marshall Islands Revised Code, Chapter 19, the *Food Safety Act*, 2010, with the objectives to reduce children's exposure to promotion of unhealthy food and sugar sweetened beverages and to reduce children's consumption of unhealthy food and sugar-sweetened beverages.
- 8. The establishment of the RMI Donor Round Table Working Group was approved by the Cabinet. The Working Group will provide general and technical support to ensure effective development assistance discussions amongst the development partners and the RMI to contribution to the National Strategic Plan, National Infrastructure Investment Plan, and

National Adaptation Plan. The members of the Working Group are representatives from the following Ministries, Agencies, and Offices: Office of the Chief Secretary; Climate Change Directorate; Ministry of Finance, Banking and Postal Services; Ministry of Foreign Affairs and Trade; Ministry of Culture and Internal Affairs; Ministry of Health and Human Services; Ministry of Works, Infrastructure and Utilities; and Economic Planning, Policy and Statistics.

At its meeting on March 19, 2022 the Cabinet made the following four (4) decisions...

- 1. The Cabinet approved April 1, 2022 as the effective date of the tariff increase for the Airlines of the Marshall Islands (AMI.) The Cabinet further directed the AMI to do a public awareness on the reason of the tariff increase.
- 2. The bill to amend the Historic Preservation Act 1991 was approved by the Cabinet.
- 3. The Kwajalein Atoll Master Plan was endorsed by the Cabinet.
- 4. The Cabinet confirmed the retention of the Aviation Task Force (ATF) and approved the following members: Mr. Ben Graham, Chairperson; Mr. Jerry Kramer, Mr. Fred Pedro, Mr. Johnny Hawley, Mr. Christopher deBrum, Mr. Francis C. Domnick. The ATF will maintain dialogue and engagement with aviation, tourism, and private sector interests, provided that no commitment can be made without approval of the Cabinet.

On April 4, 2022 the Cabinet made the following decisions...

- 1. The Cabinet approved the RMI's participation in the 7th Our Oceans Conference in Koror, Palau from April 13 April 14. The delegation was led by Ministry of Natural Resources and Commerce John Silk.
- 2. The Cabinet appointed Ms. Linda S. Murnane to serve for a two-year term with a second two-year term subject to cancellation by the Government.
- 3. Mr. Randel Sylvester was appointed by the Cabinet to the Workers Compensation Task Force.
- 4. The Cabinet approved RMI Civil Service Reform Framework that encompasses Strategies and Action Plans to help guide the Public Service Commission and the Office of the Chief Secretary to implement civil service reforms in the RMI, inclusive of all State-Owned Enterprises and departments under all Ministries.

At its meeting on April 5, 2022, the Cabinet appointed Ms. Amenta Matthew as a Commissioner of the Public Service Commission for a term of three (3) years.

On April 8, 2022, the following decisions were made by the Cabinet...

- 1. Ms. Emma Kabua-Tibon was appointed as the Chairperson and Kwajalein Mayor Hirata Kabua appointed as a member for RMI Environmental Protection Agency (EPA) Board by the Cabinet.
- 2. The Cabinet approved the Rebbelib 2050 National Transport Decarbonization Framework. The Minister of Education, Sports and Training was authorized to establish a working group/taskforce to maintain and commit to the goals and in line with the National Determined Contributions.
- 3. The Cabinet appointed Senator Tony Muller, Mr. Alanso Elbon, Mr. Charles Stinnett, Mr. Sherwood Tibon, and Uliga Councilwoman Mrs. Neilani Ackley as a member of the Board of Directors of the Marshall Islands National Telecommunications Authority.
- 4. Senator Stephen W. Philip, Mr. Fred Pedro, Mr. Biten Lanki, and Mr. Jerry Nathan were appointed by the Cabinet to the Board of RMI Ports Authority.

On April 14, 2022, the Cabinet made the following four (4) decisions...

- 1. The Cabinet extended the State of Emergency on COVID-19 for 31 days and reinstated Executive Order on Fines and Penalties for person(s) who breaches the GRMI Travel Advisory and Quarantine Measures.
- 2. The Cabinet approved the development of the Delap Park to become a multi-purpose and international class infrastructure, subjected to the following: full detailed and approved design of the Park by the President undertaken by the Ministry of Works, Infrastructure, and Utilities; a public hearing of this project and securing necessary funding; and special emphasis on justifying the purpose of this undertaking due to climate change and its impact on the government land area where prioritized protection has been recognized and now planned accordingly.
- 3. The Cabinet approved the proposal by the Ministry of Health and Human Services to construction a new Rita Health Center that is to be located on the new Majuro Track & Field Site in Jenrok.
- 4. The Cabinet appointed the Chief Secretary as the Chairperson of the Committee to recommend ways to mitigate the impact of the global high inflation and cost of living and services. The Chief Secretary will select other members of the Committee to develop terms and references.

At its meeting on April 21, 2022, the Cabinet made the following two (2) decisions...

- 1. Assistant Attorney General Davina Nathan was appointed by the Cabinet as the Acting Registrar for Resident Domestic and Authorized Foreign Corporations.
- 2. The Cabinet approved the renaming of the Digital RMI Project Steering Committee to Telecommunication Program Steering Committee. Minister Kitlang Kabua was reappointed by the Cabinet as the Chair of the Telecommunication Program Steering Committee and approved the National Cybersecurity Taskforce to continue with its current membership as a subcommittee of the Telecommunication Program Steering Committee.
