Melele in:

1. Armej ro rej konaan drelone tok Majol in rej aikuj register ilo ien eo ej driwoj link ko nan register jen STP working group eo.
2. Elane emoj an approve registration eo, armej ro ren wonmaan lok wot kakolkol nan COVID-19 mokta jen aer maron ka tok nan RMI
3. Ilo an armej topar tok RMI, renaj bar kakolkol juon allen ilo airport. **ENGLISH:**

Cabinet has approved a recommendation to delay the easement of RMI's borders that was initially scheduled for October 1<sup>st</sup> 2022, to now be implemented in 13<sup>th</sup> January 2023.

What does this mean:

1. Individuals wanting to enter the RMI must STILL register with the RMI STP working group monthly
2. Once registration is approved, individuals must abide by the usual testing requirements for the Safe Travels Program
3. Upon Arrival in the RMI, a RAT test will be administered, and individuals will be allowed to return to their respective homes (or hotel) for 5 days quarantine
4. If positive, individuals will be referred to the RMI MOHHS for further evaluation and will need to home quarantine for 5 days

NDC once again urges the public to:

- Be socially responsible
- Protect vulnerable individuals in your household by Continue Good Hand Hygiene and limited physical interaction.
- Look Out for Health Advisories and Government Directives
- Comply with Public Health measures
- Implementation of mask wearing mandate for the next 3 months
