## ENGLISH:

### RMI to Open Borders

On 1 September 2022, the Cabinet met and approved opening of RMI's border on 8 September 2022.

Incoming international travellers will no longer be required to register through the Safe Travels Program (as it will cease to exist after 7 September 2022). Travelers will have to book their journeys into the RMI directly with United Airlines and other international airlines.

The **only requirement to book or buy a ticket**, will be for a passenger to submit a copy of their COVID-19 vaccination card to UA. 6 months+ to 4 years old (the youngest group to receive the COVID-19 vaccine) are required to be fully vaccinated effective by 1 October 2022. They will join 5 yrs and older on requirement to be fully vaccinated before entering the RMI.

On arrival, the current protocols approved by Cabinet will still remain in place (until further notice).

#### **Prerequisites (pre-travel) to RMI**

- Fully vaccinated against Covid-19: Primary series and boosted as eligible.
- Mask wearing enroute and practicing good hand hygiene.

#### **Upon Arrival in the RMI**

- Testing on Arrival in RMI
- Rapid antigen test (Ag-RDT): Treatment as appropriate.
- Five days home quarantine/isolation. If negative rapid antigen test on



arrival, can move around in public but must mask up.

- Anyone that initially tests negative on arrival and later develop symptoms consistent with COVID-19, should report to a health facility for COVID-19 testing and access to therapeutics (if eligible).
