Cabinet Decisions

On March 7, 2024, the Cabinet made the following 3 decisions:

- 1. ...Approved the replacement of Woja Councilman Mr. Randy Jack to Jeirok Councilman Mr. Jina David as member of the Majuro Atoll Waste Company (MAWC) Board of Directors.
- 2. ...Approved the Promulgation of Insurance to facilitate the cooperation between Insurance carriers and their obligations under the Workers Compensation Act and to supervise its activities and provide procedural mechanisms for resolving insurance complaints.
- 3. ...Appointed the following individuals to comprise and serve of the Compact Implementation Committee:

 - b. Minister Kalani Kaneko
 - c. Minister David Paul
 - d. Minister Ota Kisino

On March 14, 2024, the Cabinet made the following 3 decisions:

- 1. ...Approved Nitijela Resolution and Bill 2023 Compact, as Amended Resolution of 2024 and 2023 Compact of Free Association, as Amended Implementation Act, 2024.
- 2. ...Endorsed the National Security Office (NSO) Bill and authorized the Minister of Justice, Immigration, and Labor to introduce the NSO Bill in the Nitijela.

3. ...Approved in Principle the Republic of the Marshall Islands' submission to the International Court of Justice (ICJ.)

On March 18, 2024, the Cabinet made the following 3 decisions:

- 1. ...Approved the final re-assignment of the Duties and Responsibilities (Amendment) Act 2024 and Office of the Chief Secretary (Definitions of Powers, Functions, Duties and Responsibilities) Act 2024;
- 2. ... Approved the adoption of the Republic of the Marshall Islands (RMI) Building Act;
- 3. ...Approved in principle the final draft version of the National Drought Contingency Plan (NDCP).

On March 21, 2024, the Cabinet made the following 2 decisions:

- 1. ...Approved the positions of a Civil Engineer/Inspector and Office Engineer for the Project Management Unit (PMU) of the Ministry of Public Works, Infrastructure & Utilities.
- 2. ...Adopted, accede, and ratify to the *Agreement on Port States Measures to Prevent, Deter, and Eliminate Illegal, Unreported, and Unregulated Fishing (PSMA).*

On March 28, 2024, the Cabinet made the following 2 decisions:

- 1. ... Approved the Response Plan for the Drought and Inundation;
